- All displays must be Arts, Crafts or Re-found, Re-Purposed Treasurers, Vintage and Antiques **No import items**
- Exhibit areas are **10' wide** and **power is available upon request**. We reserve the sole right to assign spaces
- Weather is not a condition for a refund
- As a thank you to our participants, free coffee and donuts will be provided, Saturday, 8 – 9 AM in the Chamber Office
- **Designated Vendor parking is provided and will be enforced**
- Booths must be fully set up when show begins at **5:00 PM Friday**. Exhibitors **CAN NOT** work out of the back of vans, cars, or trailers
- You must notify LACC by **June 19** of cancellation to receive a 50 % refund. (616) 897-9161
- Vendors will be responsible for collection of their own sales tax and for acquiring a sales tax license
- The selling of unlicensed goods is strictly prohibited by State law
- Security will be provided for Friday night
- **Application deadline: TUESDAY, MAY 19, 2020**
- Booth fee must accompany application along with self addressed, stamped envelope
- Jury decisions will be mailed
- Submit complete description of exhibit
- Send 3 to 5 representative pictures and booth shot. We can view your pictures on-line or you may email j-pegs of your work
